SUMMARY

The year 2024 was marked by the adoption in March of the new monitoring and evaluation policy of AFD Group, which aims for more influential and useful evaluations, better articulated in the appraisal-monitoring-evaluation continuum, carried out “by our partners’ side” (in partnership) and “tailor-made” (methodology and timing adapted to the need). These inflections started to be deployed this year, with a phased implementation in 2025 and beyond.

In 2024, AFD had 72 projects evaluated by independent consultants (achieving an evaluation effort rate of 52%) with good geographical and sectoral coverage and a balance between ex-post and ongoing project evaluations, for better operational learning. Also completed 5 broad-scope evaluations (including the Health in Common Initiative/ AFD covid-19 response evaluation, the CAF partnership evaluation or the Indonesia country evaluation from a SDG perspective) and 5 impact evaluations (including the impact evaluation on clean cooking in Sahel). Most of these works have been made publicly disclosed on afd.fr and afd open data, as well as other platforms (including the Court of Auditors).

The 2025/2027 evaluation work program exercise was conducted starting from the collection of internal needs, both operational and strategic and at the Group perimeter (including Proparco and Expertise France).

Evaluation work program focuses on:

- Exercises that contribute to geographic intelligence (country evaluations Lebanon, Turkey, Vietnam, regional cooperation between French overseas territories and neighboring countries, focus on new geographies of the European neighbourhood),
- Joint or partnership evaluations (Mutual Reliance Initiative with KfW and the EIB, co-financing with the EBRD, climate facility IDFC with BOAD, other public development banks) that feed into the mobilization/partner axis,
- Exercises contributing to the debate, for topics on the international agenda (SDG alignment, COP Belém/ Forests Congo basin/Amazon basin, development financing/Policy lending, stakeholders transformation), and
- Which provide a more comprehensive picture of interventions at the Group level on topics such as entrepreneurship in Africa, infrastructure and access for vulnerable populations, or migration.

2024 ANNUAL REPORT

One year after the validation of the new AFD Group Monitoring and Evaluation Policy, changes are already materialized in this 2024 report.

The policy aimed at more influential evaluations, able to guide action and decision. Half of the project evaluations were carried out this year in the course of a project (mid-term or final, vs. ex-post), and more in the form of “clusters” of projects evaluated, giving the possibility of increased learning for operations, since they can be reinvested more directly in action. In the same vein, and as an illustration, the broad-based evaluation of Health in Common, on the response to the COVID-19 crisis, has made it possible to define broader recommendations for the Group’s action in crises; the impact evaluation of a project to make gas stoves available (Burkina) fed internal reflections and AFD’s contribution to the summit on clean cooking; Evaluation of the funding and implementation of the Resettlement Action Plan in two water and electricity infrastructure projects (Chad and Ghana); capitalisation of the AFD’s environmental and social claims management system.

The «by our partners’ side» dimension is reflected in a first joint partnership evaluation with a development bank (CAF); and through several exercises focusing on specific countries (SDG Indonesia, Climate policy loans in Colombia...), or a region (Sahel, Mediterranean ecosystem), contributing to geographic intelligence.

The range of methodologies used has finally been expanded, with a «tailor-made» approach that is better adapted to expectations. In addition to the scientific impact evaluations, which are still very present, and the broad-scope evaluations, several cross-analyses (review and scoring of project completion reports in the Sahel, synthesis of project evaluations in the Sahel, Senegal, comparative analysis of Policy loans in Indonesia-Mexico...) have made it possible to exploit the very rich flow of lessons derived from projects decentralized evaluations. The contribution analysis allowed to refine the evaluation of public policies (Climate policy loans in Colombia). Evaluations conducted by internal experts (including from the water and sanitation sector) improved internal knowledge and practices in financing the last mile of water access and strengthened partnerships with counterparts. Experience capitalization also fed into internal strategic thinking.

Some evaluations and capitalizations have also allowed us to start addressing the axes of the new AFD Group Corporate Strategy, including a capitalisation on citizen participation in the Water, Sanitation and Hygiene sector (Côte d'Ivoire), or the evaluation of a first non-earmarked credit line to support the transition of financial institutions (IDC bank in South Africa).

The following sections present in more detail the 2024 achievements for the different types of evaluation exercises used at AFD to address learning, decision support and accountability issues (project evaluations, broad-scope evaluations, scientific impact evaluations) and review disclosure, communication and dissemination activities.


1.1 Project evaluations

Project evaluations are designed to foster dialogue with stakeholders on the results of our interventions, thus fostering mutual learning. These evaluations are most often carried out by independent consultants, led in the field by AFD agencies with methodological support from the Evaluation and Learning department at headquarters.

For the year 2024, with 72 projects evaluated, the “evaluation effort rate” reached 52% and is in line with the average observed for 2021-2024.

Half of these project evaluations were carried out ex-post (a few years after completion) for accountability purposes and the other half at the mid-term or end of the project to guide ongoing projects or the construction of subsequent phases. 40% of these projects are evaluated within the framework of «clusters», for more representativeness and cross-learning between projects.

The sectoral distribution of projects evaluated over the period 2021-2024 attests to a satisfactory coverage of AFD’s main investment priorities¹.



Regarding the geographical distribution, it should be noted that 38 of the 72 projects evaluated in 2024 were implemented on the African continent. This proportion was 64%² on average over the period 2020-2023.

The activity in the French overseas territories is mainly in the form of overall budget support, which explains the low number of project evaluations. In the area of Latin America, AFD’s mandate is relatively recent. With the completion of the first generation of projects, the evaluation portfolio is growing (26 projects scheduled for evaluation between 2025 and 2026).

1.2 Broad-scope evaluations

Broad-scope evaluations may be thematic, sector, geographic or financial instrument. They cover a wider scope and longer time period than project evaluations. These evaluations may also include sectoral, geographical or cross-cutting strategies.

In 2024, 5 broad-scope evaluations were completed:

The evaluation of the **AFD Group’s contribution to the SDGs in Indonesia (2015-2022)** highlights the relevance and positive impact of funded projects. Despite a smaller financial volume than the multilateral institutions, AFD plays an essential role in supporting strategic actions aligned with Indonesian priorities in the environment and energy sectors. Contribution to the development trajectory of the country is qualitative and targeted. It is based on the establishment of a public policy dialogue on key reforms (taxation, climate finance in particular) and progressively integrates the SDGs. The evaluation recommends continuing efforts, deepening the SDG approach and providing more support to the private sector. It calls for better mobilisation of all the financing tools and more use of

synergies between entities of the Group. The results are published in the collection; it *ExPost* ([Ex-Post n°107](#)).

The Health in Common initiative, launched in April 2020, was a major response by AFD to the COVID-19 crisis. What results and lessons can be learned from this Initiative set up as quickly as possible to respond to a health crisis? The evaluation of projects in the first nine months shows AFD's ability to respond quickly, building on existing partnerships and simplifying its procedures. The initiative responded well to France's objectives of being present in Africa in the face of the crisis, and to the needs of governments and local stakeholders. Tangible results were observed: funded projects contributed to screening, health emergency management and understanding of the disease. Areas for improvement have been identified for AFD and Team France in the event of future crises. These results have been published in the *ExPost* ([Ex-Post n°104](#)) [and Evaluation History](#) collections.

The joint evaluation of the partnership between AFD Group and the regional development bank CAF (Corporación Andina de Fomento, present in Latin America and the Caribbean) covered 15 years of cooperation in all its dimensions: institutional, financial and technical via AFD and Proparco, research, staff exchanges... It highlights the relevance and coherence of an alliance that has facilitated the alignment of the two institutions' strategies around climate and biodiversity, including within IDFC (International Development Finance Club). There is room for improvement in terms of efficiency, particularly with regard to co financing, which is limited by institutional specificities (ex project cycles, environmental and social safeguards, procurement). The recommendations focus on strengthening financial cooperation and steering of the alliance, including a global strategic vision in the updated cooperation framework, and prioritising themes of mutual interest. The results will be published in *ExPost* during 2025.

The evaluation of the **inclusion of issues related to the marine and coastal ecosystem in the AFD Group's interventions (2008-2021)** shows that the Group has adopted an ecosystem approach to oceans, unlike most of its counterparts, that focus on the sustainable blue economy dimension. The analysis also highlights internal mechanisms for *ex ante* analysis of biodiversity issues, with the advantage of addressing marine biodiversity in a "positive" approach, rather than solely through the prism of "risks". These mechanisms, however, still need to be refined, as monitoring of impacts remains very limited in the absence of clear objectives and appropriate indicators and monitoring mechanisms. While the evaluation highlights the novelty and complexity of the topic, it also notes the efforts made by the Group in recent years. These results, published in the *ExPost collection* ([Ex-Post no. 102](#)), have enabled the Group to engage in internal collective reflection and dialogue with its Tunisian partners.

The evaluation of AFD's support for decentralization (2010-2022), at the intersection of three sectors (governance, urban development and agriculture), highlights the relevance of interventions in relation to the needs of local stakeholders and political and legislative contexts. The results are also satisfactory in terms of investments and strengthening local authority project management. They are more mixed in terms of territorial planning, strengthening local governance and supporting national processes for implementing decentralization reforms. In a context where these reforms often struggle to materialize, the evaluation recommends that AFD clarify its strategy between two options: a proactive approach to support decentralization (in the political and institutional sense, including sustainable community empowerment, support for local democracy and a territorial approach to development); or (ii) more targeted support for community empowerment. These results will be published in the *ExPost collection* during 2025.

1.3 Impact evaluations

Scientific impact evaluations are designed to measure the effects of an intervention on populations or ecosystems, explain the mechanisms that led to these impacts, and rigorously analyse the causal link between the intervention and these effects. Given the current lack of knowledge about the effects of development actions, this type of evaluation mobilizes approaches from research.

At the end of 2024, AFD has 24 impact evaluations in progress and some 20 exercises in the process of being implemented. They are mainly carried out on the African continent and in particular in the sectors of water, education, health as well as rural and urban development. The completion of an impact evaluation takes on average 3 years and requires large budgets that are mobilised within project budgets or through research partnerships (notably with IRD³). These evaluations are based on different methodologies depending on the context and issues, including mixed quantitative and qualitative methods that allow more projects to be reached.

This type of evaluation based on scientific methods of analysis responds to the challenge of demonstrating the impacts of AFD's interventions. After a strong increase over the last 3 years, the number of evaluations of this type should stabilize in order to consolidate these recent achievements. Indeed, impact evaluations are based on cooperation involving research units from the south and are the subject of knowledge production, dialogue and/or capacity building with our partners, as well as promotion through specific publications throughout their implementation.

Five key exercises were completed in 2024:

Impact evaluation on fish-rice farming in Guinea. Since 1999, AFD, through the National Directorate of Fish Farming (DNP) and then the National Aquaculture Agency of Guinea (ANAG), has supported three successive projects to develop fish-rice farming in forest Guinea. These projects, supported by the French NGO APDRA Pisciculture Paysanne, promoted extensive but commercial fish farming and integrated into family farms. An impact evaluation carried out by the TERO firm combining surveys and interviews with project stakeholders and fish farmers highlighted conclusive results on the living conditions of fish farmers (economic activity, food security, resilience, etc.) These results, published in the ExPost ([Ex-Post n°106](#)) and [Histoire d'évaluation](#) collections and valued at the 2025 Salon de l'agriculture, serve to document this growing sector, and more generally on the key factors of success of rural development projects.

Impact evaluation of the project to support demand for LPG gas stoves in Burkina Faso. Funded by the PAIRES programme in partnership with the IRD, the Université Paris Dauphine – PSL and the Centre Muraz, the REDGAS evaluation analysed the impacts of making available LPG stoves, coupled with financial incentives for 800 urban households in Burkina Faso. The study conducted before the summer of 2023 showed that the impacts vary according to households: even if adoption is high for all, there is a decrease in biomass consumption and therefore exposure to pollution only in households that bought their wood. If households collect their wood for free, they will only increase their total energy consumption. The results were published in the ExPost collection ([Ex-Post n°105](#)) and QDD ([QDD n°85](#)) and contributed to the AFD Group's roadmap for clean and efficient cooking.

Impact evaluation of the Tond Laafi Health and Social Protection Scheme (DSPS) for vulnerable families in Burkina Faso. The AFD has financed a compulsory health insurance scheme coupled with the offer of microcredit to informal entrepreneurs from the Yikri institute in Burkina Faso. The scientific

evaluation, carried out in partnership with the University of Bordeaux, CEPED and the Heidelberg Institute for Global Health, is based on data collected from 1,095 beneficiaries of the microfinance institute. It measured a positive impact of mutual membership on the quality and frequency of care, financial security and health. This evaluation was the subject of a scientific publication. A publication in the AFD ExPost collection is planned for 2025.

Evaluation of the impact of a microcredit scheme on household well-being in Madagascar. A team from the University of Bordeaux evaluated the impact of a microcredit scheme for micro-entrepreneurs supported by the VAHATRA Microfinance Institution in Madagascar. The study shows a positive impact on the economic situation of the beneficiary and its household, their level of education and access to basic services. Thanks to additional funding from the PAIRES programme, the evaluation also analysed the positive impact of microcredit on women’s empowerment and reporting of domestic violence. A publication in the AFD ExPost collection is planned for 2025.

Impact evaluation of an energy efficiency improvement project for housing in Ulaanbaatar. The project “Switch-Off Air Pollution” (SOAP), implemented by the NGO Geres as part of the EcoDev program, aims to develop a market for housing renovation by facilitating both the supply (certification, communication) and the demand for renovations (via an online platform to simplify the entire renovation process). Given the original objective of the approach, which was to act at a systemic level, the evaluation relied on the contribution analysis method. A special feature of the approach is the reconstruction of the project’s theory of change, with a strong investment by Geres' teams. The evaluation shows that the various renovation stakeholders have been able to take advantage of the integrated platform thanks to the complementary support provided by the programme (such as renovation training). The craftsmen have carried out many renovations outside of the platform, especially for smaller projects. The project has contributed well to developing these dynamics although in the end the total number of renovations remains negligible at the city level.

1.4 Disclosure and communication

As of 01/03/2025, there are 392 projects whose evaluation summaries are disclosed on the AFD website and afd open data (276 at the end of 2023). In accordance with the guidelines of the new evaluation policy, the AFD standard financing agreements were amended in June 2024 to allow full publication of the evaluation reports (instead of a summary), unless otherwise requested by the project owner concerned. Implementation will be gradual as new AFD agreements are put in place.

More than one hundred broad-scope evaluations are published by AFD. They were also referenced in the citizen platform for public policy evaluation set up by the Court of Auditors.⁴

In order to make the lessons learned from evaluations accessible to a non-expert audience, the new format, entitled “Histoire d’évaluation”, has been made permanent with 10 sheets already available online.

Several events in France and abroad have also allowed not only to develop partnerships with networks of experts in the field of evaluation, but also to better publicize the results of evaluations to the general public:

- The Impact Measurement Summit, held on April 18, 2024 at the Economic, Social and Environmental Council (EESC), which was closely followed by the world of the French social and include business and beyond, gave AFD strong visibility to the evaluation and measurement of impacts (on the theme Sport and development in 2024, the 2025 edition is being prepared for May 16th with a focus on the SDGs);⁵
- A conference on the scientific impact evaluations and the partnership with the IRD and the academic world of the south was organized at AFD on October 1st, 2024.
- Active participation in the OECD's Evalnet network also allows for better coordination with the evaluations of other agencies. For example, the results of AFD's evaluation of the Covid response through the Joint Health Initiative were evaluated as part of the overall evaluation of responses to the Covid pandemic coordinated by OECD.
- AFD also co-organizes the Summer Schools of the Development Chair of the Nobel Prize winner Esther Duflo. It took place in Morocco in July 2024 and the 2025 edition will take place in Dakar. To prepare for this deadline, AFD co-organized with the African Centre for Advanced Studies in Management (CESAG) and the Global Initiative for Evaluation (GIE) in November 2024 a Public Policy Evaluation Day in Senegal which brought together all the Senegalese entities responsible for evaluating priority programmes and public policies (Presidency, Primature, Court of Auditors, Ministry of Economy, Planning and Cooperation in particular).⁶
- The evaluation department of AFD has continued to be requested for various interventions with French institutions in Paris and in the provinces: Interventions/training at an international conference in Marseille, at the Pôle Clermontois de développement international, the INSP, at Paris-Dauphine University, Bordeaux School of Economics, Sciences Po Paris, Lyon and Bordeaux or the Ecole Nationale des Ponts et Chaussées.

EVALUATION WORK PROGRAM 2025-2027

This three-year evaluation work program runs from 2025 to 2027. The forecasts for 2026 and 2027 are given as an indication and allow us to anticipate the evaluation work that would have to be carried out at a later date or whose content remains to be refined. Evaluations may also be requested in the process as required.

For this period, the evaluation work program is as follows:

- Evaluations already identified or in progress for 168 projects, allowing to maintain an evaluation effort rate of 50% of completed projects over the evaluation work program period.⁷
- 15 broad-scope evaluations in progress and 14 others at feasibility stage or to be confirmed.
- 24 ongoing impact evaluations and 14 others are in the feasibility and funding search phase.
- Finally, work to capitalize experiences or reviews (synthesis and cross-analysis of evaluations) are also identified.

The three-year evaluation work program exercise was conducted starting from the collection of internal operational and strategic needs and to the Group scope whenever possible.

In the spirit of the Group's new monitoring and evaluation policy, which calls for more strategic evaluation work program, this evaluation work program seeks to focus on evaluation work that is directly useful in guiding strategic and operational decision-making and contributes to reflection and accountability on the major commitments of the AFD group within its corporate strategy.

A summary table shows the strategic evaluations:

- (a) providing a better overview of the Group's interventions;
- (b) feeding geographic intelligence and in particular country strategies;
- (c) contributing to the partnership reflex and mobilization efforts;
- d) informing the main sectorial priorities for investment, the Group's cross-cutting issues and the Group's SDG alignment (from ex-ante promises to ex-post measured results and impacts).

a) Group Vision

The Group dimension of the new Monitoring and Evaluation Policy calls on the three entities to work more closely together to i) provide a better overview of the Group's interventions and ii) learn from each other. The teams in charge of monitoring and evaluation⁸ meet more regularly to reflect together on the synergies to be developed in a sector logic.

This Group dimension is already reflected in the evaluation work program with many that will be conducted to the Group scope (see summary table): country evaluations, evaluation on the interventions of the Entrepreneurship Support Group in Africa, evaluation of vulnerable populations'

access to infrastructures financed by the AFD Group, cross-analysis of evaluations of migration projects AFD/EF/NGOs, cross-analysis of gender mainstreaming.

The teams are preparing together for the first time a biannual report of the 2025 evaluations at the Group level. It is expected to be published in May 2025 for the presentation of AFD Group results

b) Geographic axis

The country strategies are a crucial link in order to adapt the ambitions of the Group's POS 5 to the context. The AFD's board of directors is therefore naturally very interested in the evaluation exercises carried out on this country network and on the Group perimeter prior to the definition of country strategies.

ISR/EVA supports this objective through four types of exercises, depending on needs and anticipation: 1/ a comprehensive country program evaluation, 2/ a cross-analysis dealing with some evaluative questions when the content of existing evaluations allows it (e.g.: on Senegal in 2024), 3/ an annex summarizing the conclusions of existing project evaluations and 4/ a support for capitalization on cross-cutting issues (policy loans, gender, etc.)

Country program evaluations are being finalised on Lebanon (evaluation of 25 years of AFD's involvement in Lebanon) and will be launched in 2025 on Turkey and Vietnam. **The Turkey country program evaluation** will cover the last 10 years of the Group's involvement in this country. It will be based on a comprehensive portfolio analysis and three case studies with sample project review on i) support to the banking sector and convergence of standards, ii) support to municipalities (Izmir, Istanbul) and strengthening of stakeholders and iii) the support to resilience of territories and low-carbon trajectories. It will also be able to benefit from the conclusions of evaluations of recent projects or in the process of finalization (Forest Policy loans, lines of credit "Gender mainstreamin" with the bank TSKB). **The Vietnam country program evaluation** will focus on some operations that allow to analyze the reality of the partnership relationship and public policy dialogue between AFD Group and the Vietnamese counterparts. It seeks to answer a central evaluative question: to what extent have the positioning and activity of AFD Group since 2017 contributed to the operationalization of Vietnam's resilient, low-carbon climate transition path?

An evaluation of **AFD's support to the regional cooperation between French overseas territories and neighboring countries** (within the three ocean basins) will help to inform the strategic contribution of AFD requested by the Ministry of Overseas Countries and Territories.

Over this period 2025/2027, the activity will also **contribute to the learning agenda on the more recent geographies of interventions in the European neighbourhood (Caucasus/Central Asia, Western Balkans)**. As early as 2025, a first set of project evaluations will be finalised which can inform how tools such as public policy lending associated with technical cooperation (implemented in particular by EF) or lines of credit have enabled the Group to implement new geographical mandates: Energy policy lending in Albania, Policy loans on Green economy in Uzbekistan, Policy loans Economic governance in Armenia, line of credit to the Armenian bank NMC for energy efficiency in housing.

In 2026, it should then be possible to evaluate the first operations in Serbia (policy loans on urban and climate sector): this evaluation will assess how much these first operations were able to contribute and in what way (Law, decrees, tools, capacity building) to the European convergence agenda.

An evaluation of the AFD Group's contribution to the France-ASEAN partnership is also being studied, in a context where initial support in the areas of air pollution and marine waste management with EF

will end by 2026 and where the European Commission (DG-INTPA) is currently finalising an evaluation of its cooperation with ASEAN (2014-2024).

This geographic axis of evaluation work program will be regularly supplemented in conjunction with the revision calendar of country strategies expected for 2026 and 2027.

A special dialogue in the field of evaluation of public projects and policies is also underway with:

- Côte d'Ivoire (signature in July 2023 of a memorandum of strategic dialogue between the AFD and the Ministry of Planning around evaluation, high-level training, joint evaluations on projects of the educational continuum financed by the Debt Reduction-Development Contract (C2D), in discussion the transversal evaluation of the C2D in Ivory Coast, to be piloted jointly between this country and France) and
- Senegal (high level of attention from the new authorities regarding evaluation of public programs and policies, national workshop organized in November 2024 in Dakar, organization in July 2025 of the summer school of the Esther Duflo Development Chair in Dakar, joint evaluation with the French Treasury of the Dakar express regional Train (TER) project involving all Senegalese entities, preparation of evaluations of AFD support in advance of the Youth Olympic Games Dakar 2026).

c) Partnership/Mobilization

This axis is a reflection of axis 2 of the new Policy, which aims at evaluations thought and conducted "by our partners' side" (more partnership or co-piloting, for shared accountability).

An evaluation of the Mutual Reliance Initiative (MRI) to be conducted jointly with the EIB and KfW. Launched in 2013, the MRI Initiative is based on a mutual recognition mechanism of procedures between the three partner institutions to facilitate co-financing by allowing a number of tasks to be delegated to one of the co-funders designated as "Lead", which executes them for the common account in accordance with its own procedures. The evaluation is being started but the idea is to be able to examine this partnership in a global way by addressing both common issues for the three banks but also questions specific to each lessor. A review of the entire co-financed portfolio will be conducted and case studies on a small sample with field mission will be planned.

Project evaluations jointly with EBRD: evaluation of energy credit lines in Morocco initially under EBRD lead, followed by an evaluation of the co-financed project in the solid waste sector in Serbia in 2026.

The evaluation of IDFC's Climate Facility, conducted jointly with BOAD in 2024, is being finalized to feed the Club's reflections on the follow-up envisaged for this tool. Beyond the Facility itself, the challenge is to contribute to a more global reflection (within Finance en Commun in particular) on the support methods (technical assistance and peer-to-peer exchanges) of public development banks (BPD), to better take into account the SDGs in their strategies and financing.

Discussions continue with various public development banks clients and partners of AFD to consider joint and partnership evaluations. At the Finance in Common 2025 Summit, a session opened up a space for dialogue between BPD on the theme of impact and evaluation. In parallel, several concrete exercises were discussed with the banks present, including a joint partnership evaluation with DBSA (South Africa).

d) Sectoral priorities, cross-cutting themes, SDG alignment

With regard **to the cross-sectional arrangements ensuring SDG alignment**, evaluation work program includes:

- The independent evaluation of the Sustainable Development Analysis and independent Opinion as a whole (on the occasion of its 10th anniversary) and an initial pilot exercise to evaluate a first sample of completed projects from a sustainable development perspective. The results of these evaluations will be published in 2025;
- It is proposed to periodically conduct independent reviews on project samples in order (i) to verify the reality of the SDG alignment of projects ex-post, with reference to the SD opinion carried out ex-ante and to analyse any deviations; and (ii) Carry out an external review of project completion reports produced by the operational staff and independent validation of completed projects (in line with the pilot that was finalized in 2024 on the Sahel portfolio). External reviews of this nature are scheduled for 2026/2027;
- External monitoring of the implementation of new Monitoring and evaluation Policy of AFD group. An initial review and update of the AFD's operational roadmap will be carried out in the first half of the year. A pooling is planned with the operational roadmaps of EF and Proparco. This will provide the framework for an internal monitoring of progress made and the next progressive steps in the deployment of the policy axes. A first look by an external consultant may be commissioned.

For the evaluations aimed at informing the **main sectorial priorities of investment and the cross-cutting issues** of the Group highlighted in the corporate strategy, the following exercises can be reported:

For the **Sustainable and Resilient Infrastructure priority**:

- The evaluation of the TER (regional express train) in Dakar, covering all French financing for the project (AFD loans and linked Treasury loans), carried out jointly with the evaluation unit of DG Treasury is being launched. An effort will be made to measure the impacts of urban mobility investments in Dakar. This evaluation will involve Senegalese stakeholders;
- The evaluation of access by vulnerable populations to infrastructure financed by AFD Group began in early 2025. The purpose of this evaluation is to feed the Group's thinking and identify levers to help it improve its practices in this area. The evaluation questions will address both: (i) project design and dialogue between AFD and its counterparts (public and private); (ii) the design of the infrastructure itself (including the issue of targeting disadvantaged populations); (iii) The issues related to the operation of services and their necessary financial balance. It will cross-reference approaches, practices and tools – and their results – implemented in the framework of infrastructure projects in the mobility, electricity, water and sanitation sectors based in particular on case studies of access projects (AFD and Proparco), and an external benchmark with other donors,
- A cross-sectional analysis of evaluations on the sustainability of infrastructure from the perspective of its operation and maintenance.

For the SDG **Economy and Finance priority**:

- The effort to evaluate budgetary financing of public policies and programmes will continue in order to strengthen the steering and accountability for the proper use of this funding modality;
- Evaluation of the interventions of the African Entrepreneurship Support Group (scoping phase in finalization);

- A cross-examination of the available evaluations of Migration projects (AFD, EF and civil society Initiative) is underway and will update the conclusions of the evaluation of the AFD's action on migration (2016-2021) completed in 2022 (Ex-post n°95, June 2023);⁹
- A capitalization/cross-analysis exercise on public development banks will be conducted as a follow-up to the exercise carried out on AFD's support for DPBs in 2021;
- A learning agenda is taking shape on the theme of "Stakeholders Transformation". The first matrix line evaluations aimed at supporting the transition of financial institutions (IDC, 2024) will feed into the focus on public development banks. Evaluations of previous supports for public enterprises and utilities reforms will also be useful. In a more transversal way, the question of the logic of accompanying transformation can be introduced into the evaluations of other interventions (loans, bond issues...) and ISR/EVA will provide methodological support for the broad-based capitalization and evaluation studies conducted on this subject by operational departments.

For the **Human Development and Social Progress** priority:

- Continuation of scientific impact evaluations in relation to "impacts bonds"/menstrual hygiene in Ethiopia, the departementalization of health mutuals in Senegal or health checks in Cameroon;
- In connection with investments to support the Youth Olympic Games Dakar 2026, the feasibility of an evaluation of the impact of local infrastructure (inclusive urban planning, jobs, inequalities);
- Several project and impact evaluations are planned within the framework of C2D Côte d'Ivoire in the field of education, training and youth employment. The specific memorandum signed with the Ministry of Planning in 2023 allows for closer collaboration with institutions and national evaluators.
- Support for Moroccan public policies in the field of health insurance and educational reform of pioneer colleges could be accompanied by pilot components with scientific impact evaluations (before possible scaling up).

On the Climate/Nature axis:

- The evaluation of all public policy budget funding related to climate and energy transition granted in Colombia since 2015, 6 policy loans, concludes and analyzes the contributions of these supporters to French influence and environmental diplomacy between the two countries;
- An important focus is given to the theme of forests both in the Congo basin (a retrospective review of AFD's action, impact evaluations using geospatial data) and in the Amazon basin (all interventions of the AFD Group and the FFEM granted between 2007 and 2024, and all types of projects and instruments (policy lending, credit lines, projects or project components,

delegation of European funds, civil society projects). The results of this work will be used for COP 30 in Belém

- Are also in progress: the evaluation of a cluster of Biodiversity projects in China, to feed the future strategy of AFD in China and for which exchanges with the ABC (Agricultural Bank of China) have taken place; the 10-year broad-scope evaluation of AFD and FFEM projects in agroecology, currently underway, has a double challenge of analysing the evolution of the approach conducted in terms of agroecology, since the capitalisation carried out on the subject in 2014; and learning for operational staff. These two evaluations will be valuable for the 2026 biodiversity COP in Yerevan.
